GENERAL RELEASE, WAIVER AND INDEMNITY AGREEMENT**

In consideration of my minor child, _____, being permitted to participate in an aquatic swim program at the Red Hawk Swim & Fitness Center, the undersigned, for myself and on behalf of my minor child, release, waive, and covenant not to sue RED HAWK LAND COMPANY, LLC, its owners, members, managers, officers, directors, shareholders, allied entities, employees, or agents (collectively, "RED HAWK"), with respect to any and all claims or causes of action that I or my child may have or which may hereafter accrue to my child or me on account of injury to his/her person or property, whether caused by the negligence of RED HAWK or otherwise, as a result thereof.

This release is intended to discharge RED HAWK from any and all liability arising out of or connected in any way with my minor child's participation in the aquatic swim program at Red Hawk. I hereby agree to assume all risks, both known and unknown, associated with or arising out of my minor child's participation in such program, and to release RED HAWK even though it might (through negligence or carelessness) otherwise be liable to my child (or his heirs or assigns).

The undersigned, on behalf of myself and my minor child, agrees to indemnify RED HAWK and save RED HAWK harmless from loss, liability, damage, or cost it may incur due to or arising out of the activities provided for hereunder or my child's participation in or proximity to any activities thereon, whether caused through his/her negligence or otherwise. This indemnification includes legal defense of any such claims by whomever made (using legal counsel reasonably satisfactory to RED HAWK), reasonable attorneys' fees and costs, and the cost of any settlement or judgment.
